Mount Hermon Chipping Days

Monday & Tuesday, October 5 & 6, 2020

Mount Hermon will provide all Mount Hermon residents with two days of chipping on October 5 and 6 between the hours of 8:00 am – 4:00 pm. This is a great opportunity to create defensible space for your home by removing unwanted shrubs, brush, tree limbs (up to 4" in diameter) from around your property. The contracted chipper will make only one stop at each residence, beginning October 5 so it is very important to have all of your trimmings at curbside no later than October 4. Get started now!

<u>What will be chipped</u>: Shrubs, tree trimming, low scrub brush. All trimming must be 4" or smaller.

What will not be chipped: Any brush/wood trimmings larger than 4" diameter; No leaves or weeds; Dirt; Tree Root balls; Construction debris/lumber.

Debris left at your property not meeting the criteria above will not be chipped and left for you to dispose of at the Ben Lomond Transfer Station.

Safety Corner >>> Fire Safety and Defensible Space

Creating and maintaining defensible space around your home and outbuildings is imperative in avoiding major damages to your property when wildfire strikes. Defensible space is the buffer you create between buildings and the vegetation that surrounds them to prevent structures from catching fire, either from direct flame contact or radiant heat. Creating ample buffer zones not only increases the chances of your home surviving a fire on its own, but it also gives firefighters a safer location from which to defend your home. In fact, fire crews are more likely to spend time defending your property if you have taken steps to limit fuel loads around your buildings.

ZONE 1: Home Defense Zone – Lean, Clean & Green

The home defense zone extends 30' out from buildings, structures, decks, etc.


- Remove dead or dry leaves and needles from yard, roof, and gutters.
- Cut or mow annual grass down to a maximum height of 4 inches.
- Trim trees regularly and maintain a minimum of 10' feet between canopies. Tree placement should be planned to ensure the mature canopy is no closer than 10 feet to the edge of any structure.
- Remove branches that overhang your roof and any dead branches close to chimney. These are known as "ladder fuels" from the ground to your home.
- Relocate woodpiles to Zone 2.
- Remove or prune flammable plants and shurbs near windows. Tree and shrubs in this zone should be limited to small clusters of a few each to break up the continuity of the vegetation across the landscape.
- Remove flammable items and plants from around and under decks and along structure walls. This includes propane tanks and anything that can be used as fuel for a fire.
- Clear vegetation from under large stationary propane tanks.
- Create fuel breaks with driveways, walkways/paths, patios and decks.
- Remove ladder fuels (vegetation under trees) so a surface fire cannot reach the crowns. Prune trees up to six to ten feet from the ground, for shorter trees do not exceed 1/3 of the overall tree height.
- Space trees to have a minimum of 18 feet between crowns with dstance increasing with the percentage of slope.

ZONE 3: Reduced Fuel Zone – 30-100 feet of Reduced Fuel

The reduced fuel zone extends beyond the home defense zone and extends to at least 100' from the house or to your property line.

- Create horizontal space between shrubs and trees.
- Create vertical space between grass, shrubs, and trees.
- Remove dead or dry leaves, needles, twigs, bark, cones, and branches from ground. This is what creates duff and is fire fuel.
- Remove small conifers growing between mature trees, especially any invasive plant, bush or tree that is high in oil content i.e. Bay Trees.
- Trees 20-30 feet from the home should have at least 12 feet between canopy tops. Trees 60-100 feet from the home should have least 6 feet between canopy tops.*

*The distances listed for crown spacing are suggested based on NFPA 1144. However, the crown spacing needed to reduce/prevent crown fire potential could be significantly greater due to slope, the species of trees involved and other site specific conditions. Check with your local forestry professional to get advice on what is appropriate for your property.

VERTICAL SPACING

Large trees do not have to be cut and removed as long as all of the plants beneath them are removed. This eliminates a vertical "fire ladder.



HORIZONTAL SPACING

Create horizontal and vertical spacing between plants, the amount of spacing will depend on how steep the slope is and the size of the plants.

- Santa Cruz County mandates wearing masks in our Post Office. It is important for all residents to follow the law and wear masks in public during the COVID-19 crisis. By the order of the Public Health Division in the County of Santa Cruz, there is a mandate to wear a mask in public places and especially indoors.
